The Presiding Magistrate of the City of San Luis Municipal Court under authority provided by the Article 6 of the Arizona Constitution, AZ Supreme Court Administrative Order 2005-32, City Codes 2.15.220 and 2.30.220, Arizona Rules of Criminal Procedure 4.3, Arizona CTBMPS Rules of Procedure 6(a), ARS 28-1553B, and in accordance with published standards and requirements of the Arizona Supreme Court regarding Special Judicial Officers hereby appoints the Municipal Judge of the City of Yuma Municipal Court to serve as a Special Judicial Officer for the San Luis Municipal Court, on a part-time/as needed basis, in order to assist in the processing of cases brought before the court.

IT IS ORDERED that, upon having met all the qualifications under ARS 22-122, in compliance with ACJA 1-305, and rules set forth by the AZ Supreme Court regarding Special Judicial Officer appointments, Gregory W. Counts is hereby appointed Special Magistrate to serve in the San Luis Municipal Court in the City of San Luis for a term beginning November 17, 2025. This appointed term shall be no less than two years and run concurrently with his position as a Judicial Officer


of the Yuma Municipal Court or until modified by the Presiding Magistrate of San Luis Municipal Court.

IT IS FURTHER ORDERED that this administrative appointment is conditioned upon the agreement that the appointee serve without compensation or benefits from the City of San Luis.

IT IS FURTHER ORDERED that the appointee may perform duties of a Magistrate in accordance with City Code 2.30.020 and as necessary or directed by the Presiding Magistrate to process Criminal Misdemeanor, Civil Traffic, Local Ordinance, Order of Protection and Injunction Against Harassment cases as well as other court proceedings assigned. This appointment as a part-time Special Magistrate serves to maintain the responsiveness of the court to the Citizens of San Luis by ensuring that legal time standards are met.

IT IS SO ORDERED.




