AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS ARIZONA AMENDING THE CITY CODE CHAPTER 112 SETTING THE BORDER AREA TAXI VEHICLE PERMIT FEE BY RESOLUTION AND MAKING MINOR CORRECTIONS TO THE CITY CODE; REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING FOR SEVERABILITY.

BE IT ORDAINED by the Mayor and City Council of the City of San Luis, Arizona:

Section 1. City Code § 72.07(B) is amended to read:

Establishment of stands. The Chief of Police, with the concurrence of the City Engineer, the Public Works Director, and the Fire Chief shall establish bus stands, taxi stands, and taxi waiting stands within “publicly owned property” as defined by § 72.04(D). All taxis, liveries, and buses shall park in the same direction as traffic flow with their wheels no more than eight inches from the curb. No vehicle shall stop, stand or park in a bus stand other than a bus, and no vehicles shall stop, stand or park in a taxi stand or taxi waiting stand other than a taxi or livery.

Section 2. City Code § 112.01(C) is amended to read:

The City Council further finds that (1) the taxi stand was relocated to the south side of Urtuzuastegui Street next to San Luis Industrial Park’s retention basin as recommended and (2) there are not as many spaces for taxicabs near the Port of Entry 1 as the former location provided.

Section 3. City Code § 112.02 is amended to add after the definition of “person” the following:

PUBLICLY OWNED PROPERTY has the same meaning as defined by § 72.04(D).

Section 4. Code Section 112.09(I) is amended to read:

The Mayor and City Council shall set the annual fee for each border area taxi vehicle permit by resolution. Said annual fee is in addition to all other fees and charges required by the City of San Luis's Transportation Business Regulations.

Section 5. In the event of a conflict between the provisions of this ordinance and any other ordinance, resolution, order, regulation, or policy of the City of San Luis, the conflicting provisions are hereby repealed, superseded, and replaced, and the provisions of this ordinance shall govern.


Section 6. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
