AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA AMENDING THE SAN LUIS CITY CODE SECTION 133.04 REGARDING MARIJUANA ESTABLISHMENTS WITHOUT A DUAL LICENSE WITH A MEDICAL MARIJUANA DISPENSARY; REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the City of San Luis ("City") seeks to protect public health, safety, and welfare by enacting reasonable regulations;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of San Luis, Arizona, as follows:

Section 1. Section 133.04 of the City Code is hereby amended to read as follows:

Operations of Marijuana Establishment or Medical Marijuana Dispensary or both to be in compliance with Zoning, Building, and Fire Codes:

- A. Marijuana establishments shall be regulated as outlined in Section 152.225 of the City Code.
- B. Any marijuana establishment, dual licensee, or medical marijuana dispensary shall be located in compliance with the City's zoning regulations. Any such marijuana establishment, dual licensee, or medical marijuana dispensary shall conduct any cultivation, processing, or manufacturing in compliance with the most current regulations of the building and fire codes of the City as adopted in Chapter 150 of the City Code.

Section 2. Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this ordinance or any part of the Code adopted herein by reference are hereby repealed.

Section 3. Providing for Severability.




