

1 RESOLUTION NO. 9

2 RESOLUTION DECLARING THE RESULT OF AND ADOPTING A CERTIFICATE
3 OF RESULT OF THE SPECIAL BOND ELECTION HELD ON MARCH 17, 1981;
4 ORDERING THE RECORDING OF SUCH CERTIFICATE AND DECLARING
AN EMERGENCY.

5 BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF
6 SAN LUIS, ARIZONA:

7 Section 1. After careful examination of the official
8 returns of the special bond election held in and for the Town of
9 San Luis on March 17, 1981, it is found and determined by the
10 Mayor and Council as follows:

11 (A) A majority of those qualified electors voting at
12 the aforementioned special bond election voted for the bonds on
13 the two questions as shown on the attached Certificate of Result
14 of Election;

15 (B) Bonds of the Town of San Luis are therefore
16 authorized to be issued and sold in the following amounts and
17 for the following purposes:

18 (i) Sewer Improvement Bonds in the amount of \$85,000
19 to aid in the construction of a wastewater treatment plant, lift
20 stations and wastewater collection lines and the purchase of
21 materials and equipment therefor;

22 (ii) Sewer Revenue Bonds in the amount of \$765,000 to
23 acquire land by lease or purchase, to aid in the construction of
24 a wastewater treatment plant, lift stations and wastewater
25 collection lines and the purchase of materials and equipment
26 therefor;

27 (C) The Mayor and members of this Council present
28 this date will execute the attached Certificate of Result of
29

1 the County Recorder of Yuma County, Arizona, and to return said
2 copy with the recording data shown thereon to the official
3 records of this body.

4 Section 2. The immediate operation of the provisions
5 of this Resolution is necessary for the preservation of the
6 public peace, health and safety and an emergency is hereby
7 declared to exist, and this Resolution will be in full force and
8 effect from and after its passage and approval by the Mayor and
9 Council as required by law and it is hereby exempt from the
10 referendum provisions of the Constitution and laws of the State
11 of Arizona.

1 CERTIFICATE OF THE MAYOR AND COUNCIL OF THE TOWN OF SAN LUIS,
2 ARIZONA, RELATIVE TO THE SPECIAL BOND ELECTION HELD IN AND FOR
THE Town ON MARCH 17, 1981.

3 The Mayor and Council of the Town of San Luis,
4 Arizona, hereby certify as follows:

5 1. Pursuant to the Resolution passed and adopted by
the Mayor and Council on February 11, 1981, an election was duly
6 and regularly held on March 17, 1981, for the purpose of voting
on two questions relative to the issuance and sale of bonds for
the following purposes and in the following amounts:

7 (a) Sewer Improvement Bonds in the principal amount of
8 \$85,000 to provide funds to aid in the construction of a waste-
water treatment plant, lift stations and wastewater collection
9 lines and the purchase of materials and equipment therefor;

10 (b) Sewer Revenue Bonds in the principal amount of
\$765,000 to provide funds to acquire land by lease or purchase,
11 to aid in the construction of a wastewater treatment plant, lift
stations and wastewater collection lines and the purchase of
12 materials and equipment therefor.

13 2. The election had been conducted and the returns
thereof made as required by law and that the total number of
14 votes cast at the special bond election in answer to the ques-
tions submitted were as follows:

19 3. Each and every person who voted at the special
bond election was a qualified elector of the Town of San Luis;
20 proof of the due and regular publication of the Resolution
calling the special bond election has been made and filed with
21 the Mayor and Council and placed upon the minutes of the Council.

22 4. The majority of the votes cast at the election in
answer to the question was in favor of the indebtedness as
23 described in the questions submitted at the election by the
issuance and sale of \$85,000 principal amount of Town of San
24 Luis Sewer Improvement Bonds, Project of 1981, and \$765,000
principal amount of Town of San Luis Sewer Revenue Bonds,
25 Project of 1981, and that the Mayor and Council hereby order the
issuance and sale of all the bonds of these issues.

26 IN WITNESS WHEREOF, the Mayor and members of this
27 Council have hereunto placed their hands and caused the same to
be attested by the Clerk and the seal of the Town of San Luis to
28 be affixed hereto on March 30, 1981.
