A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 30, 2016, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a Primary Election on the 30th day of August, 2016, for the election of three (3) Council Member seats;

WHEREAS, the 2016 Primary Elections returns have been presented to and have been canvassed by the City Council;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, that the canvass and return for the Primary Election of August 30, 2016 be as follows:

Section 1: That the total number of ballots cast at said primary election, as shown by the poll lists, was 1,790.

Section 2: That the total number of provisional ballots was as follows:

VC12-San Luis City Hall=2

Total=7

Section 3: That the total number of provisional ballots to be verified was as follows:

VC11-Cesar Chavez Cultural=5

VC12-San Luis City Hall=2

Total=7

Section 4: That the total number of spoiled ballots was as follows:

VC12-San Luis City Hall=12

Total=26


Section 6: That it is hereby found, determined and declared of record, that the following candidates did receive the highest number of votes for the office sought and shall be issued certificates of election:
