

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA ELECTING OVERLAPPING TERMS FOR THE DIRECTORS OF THE INDUSTRIAL DEVELOPMENT AUTHORITY OF THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the Mayor and City Council of the City of San Luis, Arizona, elected Directors of The Industrial Development Authority of The City of San Luis, Arizona (the "IDA"), on July 29, 2015.

WHEREAS, it is incumbent upon the Mayor and City Council of the City of San Luis, Arizona to elect overlapping terms of the IDA Directors by A.R.S. § 35-705.

WHEREAS, the IDA Directors met on November 16, 2015 and voted for their overlapping terms and recommend the same to City Council.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, State of Arizona, as follows:

Section 1: The Mayor and City Council of the City of San Luis, Arizona elect the Directors of The Industrial Development Authority of the City of San Luis, Arizona (the "IDA") to hold the following terms, starting July 29, 2015 as follows:

2 year term: Rosa Varela and Gary Black
4 year term: Francisco Magallon and Marco Pinzon
6 year term: Maria Gonzalez and Eduardo Vasquez

Section 2: The Directors of the IDA, are hereby authorized, empowered and directed, in the name and on behalf of the IDA, to take such action as may be necessary or desirable to carry out the intents and purposes of this resolution.

PASSED AND ADOPTED by the Mayor and Common Council of the City of San Luis, Arizona, this 22nd day of March, 2017.


