A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, APPROVING THE CONTINUATION OF AN INTERGOVERNMENTAL AGREEMENT (IGA) BETWEEN THE CITY OF SAN LUIS AND YUMA COUNTY FOR THE PURPOSE OF PROVIDING A FIELD TRAINER TO PROVIDE TRAINING AND UNIFORMITY OF AUTOMATION SYSTEMS FOR FISCAL YEAR (FY) 2017-2018.

WHEREAS, the City of San Luis desires to continue participation in the previous IGA with Yuma County for the provision of a field trainer; and

Whereas, all parties to the IGA desire to continue participation in said agreement;





The original Intergovernmental Agreement was signed and dated on July 2016 and further approved by San Luis City Resolution No. 1149, Section 1. B. "Court's Option to Extend" provided for "five (1) one year periods, beginning on July 1, 2016..."

It is hereby agreed upon by the parties to exercise the option to extend said agreement for an additional (1) one year period beginning July 1, 2017 and terminating on June 30, 2018. The City shall pay the Court \$1000.00 for the period covered under this extension. All of the terms and conditions contained in the original intergovernmental agreement remain in full force and effect during the extended term.
