**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, AUTHORIZING THE SUBMISSION OF APPLICATIONS FOR FY 2021 STATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS AND FY 2021 STATE SPECIAL PROJECT FUNDS (CDBG-SSP), CERTIFYING THAT SAID APPLICATION MEET THE COMMUNITY'S PREVIOUSLY IDENTIFIED HOUSING AND COMMUNITY DEVELOPMENT NEEDS AND THE REQUIREMENTS OF THE STATE CDBG PROGRAM, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATIONS.**

**WHEREAS**, the City of San Luis, Arizona, is desirous of undertaking community development activities; and

**WHEREAS**, the State of Arizona is administering the Community Development Block Grant/State Special Project Programs (CDBG-CDBG-SSP); and

**WHEREAS**, the State CDBG/CDBG-SSP Programs require that CDBG funds requested address one of three Congressionally mandated National Objectives; and

**WHEREAS**, the activities within the applications address the community's identified housing and community development needs, including the needs of moderate-and low-income persons; and

**WHEREAS**, an Applicant for State CDBG/CDBG SSP funds is required to comply with the program guidelines and Federal Statutes and regulations.

**NOW, THEREFORE, BE IT RESOLVED** that Mayor and City Council of the City of San Luis, Arizona, County of Yuma authorize applications to be made to the State of Arizona Department of Housing for FY 2021 CDBG funds and FY 2021 CDBG-SSP funds, and authorize the Mayor to sign applications, contract or grant documents for receipt of and use of these funds for "Mesa Street Improvements and Rancho Los Oros Improvements Phase 2"; and authorize the Mayor to take all actions necessary to implement and complete the activities submitted in said applications;

**THAT** the applications for State CDBG/CDBG-SSP funds meet the requirements for low and moderate-income benefit activities, aids in the prevention or elimination of slum and blight, or addresses an urgent need which poses a threat to health; and






