A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, COUNTY OF YUMA, COMMITTING LOCAL FUNDS AS LEVERAGE FOR FY 2021 COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATIONS; REPEALING ANY CONFLICTING PROVISIONS; PROVIDING FOR SEVERABILITY.

WHEREAS, the City of San Luis has adopted Resolution No. 2177 which authorizes submission of applications to the State of Arizona Department of Housing (ADOH) for Community Development Block Grant (CDBG) funds for FY 2021; and

WHEREAS, said application indicates that \$486,317.00 will be committed by the City of San Luis as leveraged funds, in the form of **cash** to be used to implement Activity #2 Mesa Street Improvements; and

WHEREAS, said application indicates that \$223,000.00 will be committed by the City of San Luis as leveraged funds, in the form of **cash** to be used to implement Activity #2 Rancho Los Oros Improvements Phase 2; and

WHEREAS, said application indicates that \$70,115 will be committed by the City of San Luis as leverage funds, in the form of **cash** to be used to implement Activity #2 Rancho Los Oros Phase 3; and

WHEREAS, the CDBG Program requires that all local leveraged funds be committed in the form of a resolution by the governing body, and that such a commitment contain an opinion by the applicant's legal counsel that the leveraged funds represent a binding commitment, legally enforceable under State laws.

NOW, THEREFORE, BE IT RESOLVED based on the foregoing and by the Mayor and City Council of the City of San Luis, Arizona, County of Yuma:


Section 1. The City Council hereby commits \$486,317.00 to the CDBG Program, to be used for the following: Mesa Street Improvements, hereby commit \$70,115.00 to the CDBG Program, be used for the following Rancho Los Oros Phase 3 (alternate application), and commit \$223,000.00 to CDBG-SSP Program, to be used for construction efforts, contingent upon the receipt of FY 2021 CDBG assistance; and that the Mayor and City Council of the City of San Luis, Arizona, County of Yuma hereby state that this commitment is legally binding

based on the legal opinion of the City of San Luis attorney, and that such funds will be available for an audit at the termination of the grant, if so required by ADOH.

Section 2. Conflicting Provisions: In the event of a conflict between the provisions of this resolution and any other resolution, regulation or policy of the City of San Luis, the conflicting provisions are repealed, superseded and replaced, and the provision of this resolution shall govern.

Section 3. Severability: If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance
