RESOLUTION NO. 292

RESOLUTION TO CANVASS VOTE



A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 17, 1994; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

WHEREAS, the City of San Luis, Yuma County, Arizona did cause to be submitted to the qualified electors of the city at an election held in and for the City on the 8th day of March, 1994 for the nomination of three Councilmembers; and

WHEREAS, the election returns have been presented to and have been canvassed by the city council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona as follows:

SECTION 1. That the total number of ballots cast at said general election, as shown by the poll lists, was 647.

SECTION 2. That the number of questioned ballots was 0, and that voters found to be ineligible were 0, and that ten ballots were spoiled.

SECTION 3. That the votes cast for the candidates for councilmember were as follows:

Luis Castro



PASSED AND ADOPTED BY the Mayor and Council of the City of San Luis, Arizona, this 25th day of May 1994.




