**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE UNITED STATES DEPARTMENT OF INTERIOR, BUREAU OF RECLAMATION TO ACQUIRE FEDERAL RIGHT OF WAY LAND AND REQUEST AUTHORIZATION FOR THE CONSTRUCTION OF COUNTY 24TH STREET.**

**WHEREAS**, the Bureau of Reclamation requires state or local governments to provide authorization to submit an application to the Bureau of Reclamation; and

**WHEREAS**, the City of San Luis requires federal right of way lands and authorization to construct County 24<sup>th</sup> street; and

**WHEREAS**, the City of San Luis wishes to submit a transportation and utility systems and facilities on federal land application; and

**WHEREAS**, said lands owned by the Bureau of Reclamation are a part of:

Co. 24<sup>th</sup> Street

The east 33' of Lots 1 and 6 of Section 7, T. 11 S., R. 24 W., G.&S.R.B.&M.

The west 33' and south 33' of Lot 4, south 33' of the SE1/4 of the SW1/4, and the south 33' SE1/4 of Section 8, T. 11 S., R. 24 W., G.&S.R.B.&M.

The south 33' of the SW of Section 9, T. 11 S., R. 24 W., G.&S.R.B.&M.

The north 33' of NW of Section 16, T. 11 S., R. 24 W., G.&S.R.B.&M.

The north 33' of the NE1/4, north 33' of the NE1/4 of the NW1/4, north 33' and west 33' of Lot 1 of Section 17, T. 11 S., R. 24 W., G.&S.R.B.&M.

The north 33' of the NE of Section 16, T. 11 S., R. 24 W., G.&S.R.B.&M

and

Avenue F1/2

The east 33' of the SE of the SE of the SW of Section 9, T. 11 S., R. 24 W., G.&S.R.B.&M.


