**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE UNITED STATES DEPARTMENT OF INTERIOR, BUREAU OF LAND MANAGEMENT TO ACQUIRE FEDERAL RIGHT OF WAY LAND AND REQUEST AUTHORIZATION FOR THE CONSTRUCTION OF COUNTY 24<sup>TH</sup> STREET.**

**WHEREAS**, the Bureau of Land Management requires state or local governments to provide authorization to submit an application to the Bureau of Land Management; and

**WHEREAS**, the City of San Luis requires the federal right of way lands and authorization to construct County 24<sup>th</sup> street; and

**WHEREAS**, the City of San Luis wishes to submit a transportation and utility systems and facilities on federal lands application; and

**WHEREAS**, said lands owned by the Bureau of Land Management are a part of:

The north 33' of the NE of Section 16, T. 11 S., R. 24 W., G.&S.R.B.&M


