A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 8, 2022.

WHEREAS, the City of San Luis, Yuma County, Arizona, held a General Election on the 8th day of November 2022, for the election of three (3) Council Members; and

WHEREAS, the 2022 General Election returns have been presented to and have been canvassed by the City Council pursuant to Arizona Revised Statutes §§ 16-642 and 16-646.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, declare the results of the General Election of November 8, 2022, as follows:

Section 1: That the total number of ballots cast at said general election, as reported by the County, was 4,210 and is set forth on the reports, attached and incorporated into this resolution.

Section 2: That the number of ballots cast and the number of active registered voters in each precinct, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 3: That the number of ballots cast in each precinct at said general election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 4: That the number of votes by precincts received by each candidate election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 5: That the number of ballots rejected in each precinct at said general election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 6: That the votes cast for the candidates for Council Members (four-year term) were as follows:




