**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, A MUNICIPAL CORPORATION OF ARIZONA, TO AUTHORIZE THE APPLICATION FOR A DRINKING WATER STATE REVOLVING FUND LOAN FROM THE WATER INFRASTRUCTURE FINANCE AUTHORITY OF ARIZONA**

**WHEREAS**, the City of San Luis, Arizona, has identified a need for a water capital improvement project; and

**WHEREAS**, pursuant to Sections 9-521 through 540, Arizona Revised Statutes, and specifically Section 9-571, Arizona Revised Statutes, such city may obligate the revenues generated by its utility system to repay a loan from the Water Infrastructure Finance Authority of Arizona ("WIFA"); and

**WHEREAS**, such city certifies that the population of the community is under 150,000 in population as of the most recent U.S. Census Date; and

**WHEREAS**, it is in the best interest of such city to pursue and apply for financial assistance from WIFA of an amount not to exceed \$13,600,000 for such water capital improvement project; and

**WHEREAS**, the population of such city at the time of this request is less than 150,000, which meets the requirement under Section 9-571, Arizona Revised Statutes;

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and City Council of the City of San Luis, Arizona, as follows:

**Section 1.** The Acting City Manager or Finance Director of such city are hereby authorized to apply for Drinking Water State Revolving Fund financial assistance from WIFA.

**Section 2.** The City Manager or Finance Director of such city are hereby authorized to take such actions as are necessary to apply for financial assistance in an amount not to exceed \$13,600,000 payable from revenues of the utility system.

**Section 3.** All actions of the officers and agents of such city which conform to the purposes and intent of this resolution and which further the completion of the application as contemplated by this resolution, whether heretofore or hereafter taken are hereby


ratified, confirmed and approved. The proper officers and agents of such city are hereby authorized and directed to do all such acts and things and to execute and deliver all such application documents on behalf of such city as may be necessary to carry out the terms and intent of this resolution.


