A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, PROVIDING FOR A CALL OF ELECTION FOR THE 2024 CITY'S ELECTIONS, A PRIMARY ELECTION ON JULY 30, 2024, A GENERAL AND SOUTHWEST GAS CORPORATION FRANCHISE ELECTION ON NOVEMBER 5, 2024, DESIGNATING THE ELECTION DATES AND PURPOSE, DESIGNATING THE DEADLINE AND LOCATION FOR CANDIDATES TO FILE NOMINATION PETITIONS AND DESIGNATING THE DEADLINE FOR VOTER REGISTRATION.

WHEREAS, the City of San Luis Primary, General and Southwest Gas Corporation Franchise Elections for 2024 are required to be held on certain dates pursuant to Arizona Revised Statutes §16-204, which are July 30, 2024, for the Primary Election and November 5, 2024, respectively for the General and Southwest Gas Corporation Franchise Election; and

WHEREAS, City of San Luis elections are required in order to fill the offices of three (3) City Council seats and for the Southwest Gas Corporation Franchise, and

WHEREAS, Arizona Revised Statutes § 9-501, et al, authorized the City of San Luis to enter into Franchise Agreements with public utilities; and

WHEREAS, the City of San Luis has had a franchise with Southwest Gas Corporation since the year 2000, but the Franchise Agreement expires in 2024.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of San Luis, Arizona, as follows:

Section 1. That July 30, 2024, has been set as the date for holding the Primary Election in the City of San Luis, Arizona, for the purpose of nominating candidates for three (3) City Council seats, terms to expire December 2028, whose names shall appear on the ballot at the Primary Election to be held on July 30, 2024. Any candidates receiving a majority of all the ballots cast at the Primary Election shall be declared elected without running at the General Election. That November 5, 2024, has been set as the date for holding the General Election.

Section 2. Candidates seeking municipal office may obtain nominations papers and other materials from the City Clerk's Office, located at San Luis City Hall, 1090 E. Union Street, beginning on Tuesday, January 2, 2024. Candidate nomination papers are required to be filed at the City Clerk's Office. The first day to file nomination papers and other forms is March 4, 2024 and the last day to file the nomination paperwork is 5:00 p.m. on April 1, 2024, at the City Clerk's Office in order for their names to appear on the Primary Election ballot. Write-In Candidates filing deadlines are June 20, 2024, at 5:00 p.m. for the Primary Election and September 26, 2024, for the General Election.

Section 3. Yuma County registration and voting lists will be used for the Primary and General Elections. In order to be qualified to vote in the Primary Election, voters must be registered by July 1, 2024. To be qualified to vote in the General Election, voters must be registered by October 7, 2024.

Section 4. That this Resolution authorizes and directs the Offices of the City Clerk and City Attorney to take further actions required by law to conduct the elections.


