A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR THE USDA RURAL BUSINESS DEVELOPMENT GRANT, CERTIFYING THAT SAID APPLICATION MEETS THE USDA RURAL COMMUNITY DEVELOPMENT REQUIREMENTS, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATION.

WHEREAS, the City of San Luis, Arizona, is committed to fostering economic development and supporting local businesses; and

WHEREAS, the USDA Rural Business Development Grant provides financial assistance to rural communities for economic development projects that benefit small and emerging businesses; and

WHEREAS, the City of San Luis seeks to establish a Small Business Assistance Fund to provide grants or low-to-no-interest loans to businesses impacted by the construction of the Cesar Chavez Boulevard Project; and

WHEREAS, the activities proposed in the application align with the City's economic development goals by supporting local businesses, maintaining job stability, and mitigating financial hardships caused by infrastructure improvements; and

WHEREAS, an applicant for USDA Rural Business Development Grant funds is required to comply with program guidelines, federal statutes, and regulations.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of San Luis, Arizona, County of Yuma, as follows:

Section 1: The submission of an application for the USDA Rural Business Development Grant is hereby approved and authorized.

Section 2: The Mayor is authorized and directed to execute all necessary applications, contracts, and grant documents required for the receipt and administration of these funds in accordance with the activities outlined in the application.

Section 3: The Mayor is further authorized to take all necessary actions to implement and complete the activities described in the application, ensuring compliance with all applicable regulations and guidelines.




