A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, COMMITTING LOCAL FUNDS FOR THE FY 2025 FEDERAL TRANSIT ADMINISTRATION GRANTS FOR BUSES AND BUS FACILITIES PROGRAM FOR THE DOWNTOWN PARK & RIDE AND PLAZA PROJECT.

WHEREAS, the City of San Luis, Arizona, intends to apply for funding through the Federal Transit Administration's FY 2025 Buses and Bus Facilities Competitive Program; and

WHEREAS, the city proposes to construct the Downtown Park & Ride and Plaza, a multimodal project which includes a 475-space parking facility and key transit infrastructure connecting to the Yuma County Area Transit (YCAT) regional system; and

WHEREAS, the project will directly support transit riders, pedestrians, and cross-border commuters, while improving regional mobility and supporting economic development in downtown San Luis; and

WHEREAS, the total eligible cost of the transit-related project scope is \$5,300,499.00 and the grant request to the Federal Transit Administration is for \$4,240,399.00; and

WHEREAS, the City of San Luis will commit \$1,060,100 as a local match to fulfill the required 20% non-federal share; and

WHEREAS, the Federal Transit Administration requires a resolution of the governing body committing leveraged local funds and a legal opinion confirming the enforceability of that commitment under state law;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of San Luis, Arizona, as follows:

SECTION 1: The Mayor and City Council find that the Downtown Park & Ride and Plaza project is in the public interest and supports equitable mobility, public transportation, and downtown revitalization.


SECTION 2: The Mayor and City Council hereby commit \$1,060,100.00 in local funds to be used as match for the FY 2025 FTA Buses and Bus Facilities Program grant, to be obligated in the City's FY 2027 budget beginning July 1, 2027.

SECTION 3: The Mayor and City Council authorize the submission of the grant application to the FTA and authorize the Economic Development Department to perform all acts necessary to implement the project and grant application, including execution of any documents or agreements required.

SECTION 4: This commitment is deemed legally binding based on the legal opinion of the City Attorney, and such funds will be made available for audit if required by the FTA at the termination of the grant.

SECTION 5: If any section, clause, or provision of this resolution is held to be invalid or unconstitutional, the remainder of the resolution shall not be affected.
