RESOLUTION NO. 376

OFFICE OF THE

CITY OF SAN LUIS

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, COUNTY OF YUMA, STATE OF ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 10, 1998; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

WHEREAS, the City of San Luis, Yuma County, Arizona did cause to be submitted to the qualified electors of the City at a primary election held in and for the City on the 10th day of March, 1998 for the nomination of a Mayor and three Councilmembers;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona as follows:

Section 1. That the total number of ballots cast at said primary election as shown by the poll lists was 913.

Section 2. That the total number of ballots to be verified and used at said primary election was 31, and that voters found to be ineligible were 5;

Section 3. That the total number of spoiled ballots was 4.

Section 4. That the votes cast for the office of Mayor were as follows:

Section 6. That it is hereby found, determined and declared of record that the following candidate did receive more than half the total number of ballots cast and will receive a certificate of election:

Section 7. That Section 2-3-1 of the Code of the City of San Luis, Arizona, pursuant to authority granted from Arizona Revised Statutes 9-821.01, provides that at a primary election a candidate who receives a majority of all votes cast shall be declared to be elected. That 457.50 votes were needed for the election of a councilmember at the primary.

Section 8. That it is hereby found, determined and declared of record that the following candidate did receive more than half the total number of ballots cast and will receive a certificate of election:

Section 9. That it is hereby found, determined and declared of record that the following four candidates for City Council did receive the next greatest number of votes of the electors of the City voting at said election and shall have their names placed on the ballot for the general election to be held on the 19th day of May, 1998, and are hereby issued certificates of nomination:






