A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 19, 1998.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a general election on the 19th day of May, 1998 for the election of 2 (two) Councilmembers; and

WHEREAS, the election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows;

SECTION 1. That the total number of ballots cast at said general election, as shown by the poll lists, was 541.

SECTION 2. That the number of ballots to be verified was 19, and that voters found to be ineligible were 2.

SECTION 3. That the number of spoiled ballots was 1.

SECTION 4. That the votes cast for the candidates for councilmember were as follows:
