A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 14, 2000.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a primary election on the 14th day of March, 2000 for the nomination/election of three (3) Councilmembers; and

WHEREAS, the election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said primary election, as shown by the poll lists, was 1037.

SECTION 2. That the number of ballots to be verified was 73, and that voters found to be ineligible were 10.

SECTION 3. That the votes cast for the candidates for Councilmember were as follows:

SECTION 4. That it is hereby found, determined and declared of record, that the following two (2) candidates did receive more than one-half of the total number of valid votes cast and are hereby issued certificates of election:

SECTION 5. That it is hereby found, determined and declared of record, that the following two (2) candidates did receive the next greatest number of votes of the electors of the City voting at said election and shall have their names placed on the general municipal election ballot of the City of San Luis, Yuma County, Arizona, to be held on the 16th day of May, 2000, and are hereby issued certificates of nomination:

Montes, Ernesto

SECTION 6. That it is hereby found, determined and declared of record, that the votes cast for the Franchise Question at said election were as follows:



SECTION 7. This Resolution shall be in full force and effect immediately upon its adoption.




