

RESOLUTION NO. 481

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, COUNTY OF YUMA, STATE OF ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY/RECALL ELECTION HELD ON MARCH 12, 2002; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

WHEREAS, the City of San Luis, Yuma County, Arizona did cause to be submitted to the qualified electors of the City of San Luis at a primary/recall election held in and for the City of San Luis on the 12th day of March, 2002, for the nomination of a Mayor, three (3) Council Members, a Recall Election for one (1) Council Member seat, and the City of San Luis, Arizona, 2020 General Plan; and

WHEREAS, the primary/recall election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona as follows:

Section 1. That the total number of ballots cast at said primary/recall election as shown by the poll lists was 1,458.

Section 2. That the total number of ballots to be verified at said primary/recall election was 232, and that voters found to be ineligible to vote were 21.

Section 3. That the total number of spoiled ballots was 17.

Section 4. That the votes cast for the candidates for the office of Mayor were as follows:

Section 9. That the votes cast at said recall election for the candidates for the Council Member position held by Gloria Torres were as follows:




