## AUTHORIZATION TO SUBMIT APPLICATION AND IMPLEMENT CDBG PROJECTS

RESOLUTION NO. 492

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR FY 2002 STATE COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS, CERTIFYING THAT SAID APPLICATION MEETS THE COMMUNITY'S PREVIOUSLY IDENTIFIED HOUSING AND COMMUNITY DEVELOPMENT NEEDS AND THE REQUIREMENTS OF THE STATE CDBG PROGRAM, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATION.

WHEREAS, the City of San Luis, Arizona is desirous of undertaking community development activities; and

WHEREAS, the State of Arizona is administering the Community Development Block Grant Program; and

WHEREAS, the State CDBG Program requires that CDBG funds requested address one of the three Congressional mandated National Objectives; and

WHEREAS, the activities within this application address the community's identified housing and community development needs, including the needs of low and moderate income persons; and

WHEREAS, a grantee of State CDBG funds is required to comply with the program guidelines and Federal Statutes and regulations.

NOW, THEREFORE, BE IT RESOLVED THAT the City Council of the City of San Luis, Arizona, authorizes application to be made to the State of Arizona, Department of Commerce for FY 2002 CDBG funds, and authorizes Alex Joe Harper, Mayor to sign application and contract or grant documents for receipt and use of these funds for Sanitation Trucks and authorizes Alex Joe Harper, Mayor to take all actions necessary to implement and complete the activities submitted in said application; and

THAT this application for State CDBG funds meets the requirements of low- and moderate-income benefit for activities justified as benefiting low- and moderate-income persons, aids in the prevention or elimination of slum and blight or addresses an urgent need which poses a threat to health; and

THAT, the City of San Luis, Arizona will comply with all State CDBG Program guidelines, Federal Statutes and regulations applicable to the State CDBG Program and the certifications contained in the this application.

Passed and adopted by the City Council of the City of San Luis, Arizona, this 24th day of April, 2002.



The Governors Office of Housing Development announced the availability of FY 2002 Community Development Block Grant (CDBG) State Special Project (SSP) Accounts funds a competitive statewide grant application round. The maximum grant available is \$300,000.00 to be expended within 12 months.

The Economic Development Department received three projects with an approximately cost of \$300,000.00 for each project. Due to a maximum grant available of \$300,000.000, the San Luis City Council was required to select one project and submit one application to the Governor's Office of Housing Development. The CDBG regulations require that the governing board adopt a Resolution selecting a project. This resolution is submitted with the application for possible funding.

Mayor and Members of the San Luis City Council adopted Resolution No. 491 for an Aerial Fire Truck to be included in the application to be submitted to the Governors Office of Housing Development.
