RESOLUTION NO. 496

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, COUNTY OF YUMA, STATE OF ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 21, 2002; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

WHEREAS, the City of San Luis, Yuma County, Arizona, did cause to be submitted to the qualified electors of the City of San Luis at a general election held in and for the City of San Luis on the 21st day of May, 2002. For the election of a Mayor, and three (3) Council Members; and

WHEREAS, the general election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona as follows:

Section 1. That the total number of ballots cast at said general election as shown by the poll lists was 1917.

Section 2. That the total number of ballots to be verified at said general election was 175, and that voters found to be ineligible to vote were 19.
