A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, TO ESTABLISH NAVOLATO, SINALOA, MEXICO AS A SISTER CITY TO CITY OF SAN LUIS IN RECOGNITION TO THE SIMILARITIES BETWEEN THE CITIES AND THE BOND OF FRIENDSHIP AND MUTUAL SUPPORT THAT EXISTS BETWEEN NAVOLATO AND OUR CITY.

Whereas, the municipality of Navolato was born when it separated from Culiacan in 1982;

Whereas, Navolato has undergone great economic development due to international commerce of agricultural products with the United States;

Whereas, the City Of San Luis offers an ideal commercial port of entry to facilitate commercial traffic;

Whereas, the City Of San Luis, incorporated in 1979, is a young city of the same approximate age as Navolato;

Whereas, the development of Navolato and the future of its economy, just like the economic development of San Luis, will focus on agricultural industries and economic diversification;


