A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA APROVING THE MEDICAL PLAN FOR FISCAL YEAR 2006-2007 OF THE CITY OF SAN LUIS AND DECLARING AS A PUBLIC RECORD THAT CERTAIN DOCUMENT FILED WITH THE CITY CLERK ENTITLED CITY OF SAN LUIS MEDICAL PRESCRIPTION EMPLOYEE BENEFIT PLAN

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA:

That certain document entitled "City of San Luis Medical Prescription Employee Benefit Plan" three copies of which are on file in the office of the City Clerk, is hereby declared to be a public record, and said copies are ordered to remain on file with the City Clerk

WHEREAS, the City of San Luis, Arizona did duly adopt the current Medical Plan on October 1, 2001 and

WHEREAS, the Mayor and Council of the City of San Luis, Arizona find that it is in the best interest of the employees of the City of San Luis, Arizona, that the revised Medical Plan for fiscal year 2006-2007 and effective as of October 2001 be adopted

NOW, THEREFORE, BE IT RESOLVED BY THE Mayor and Council of the City of San Luis, Arizona, as follows:

Section 1. That certain document entitled "City of San Luis Medical Prescription Employee Benefit Plan" three copies of which are on file in the office of the City Clerk, is hereby declared to be a public record, and said copies are ordered to remain on file with the City Clerk


Section 2. That the City of San Luis Medical & Prescription Employee benefit Plan for fiscal year revision 2006-2007 and effective as of October 2001 is hereby reaffirmed and re-approved,

Section 3. That this resolution adopts the City of San Luis Medical & Prescription Employee Benefit Plan as amended in part by revision dated July 1, 2006 and replaces any prior Medical and Prescription Employee Benefit Plan.

Section 4: In the event of a conflict between the provisions of this Resolution and any other ordinance, resolution, or policy of the City of San Luis, The conflicting provisions are hereby repealed, superseded, and replaced, and the provisions of this resolution shall govern.

Section 5: If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this resolution.
