# *Resolution*

## **RESOLUTION NO. 713**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AMENDING WATER AND WASTEWATER RATES AND CHARGES, PROVIDING AN EFFECTIVE DATE FOR SAID CHARGES, REPEALING ANY CONFLICTING PROVISIONS AND PROVIDING FOR SEVERABILITY**

**WHEREAS**, the City of San Luis, Arizona operates the water and wastewater system of the City as an enterprise fund;

**WHEREAS**, the proposed changes in rates are in accordance with a rate study conducted on 2006; and

**WHEREAS**, there is a need to adjust these rates so that proper financial planning and budgeting for fiscal year 2006/2007 may occur,

**BE IT RESOLVED** by the Mayor and City Council of the City of San Luis, Arizona, as follows:

Section 1. Wastewater rates beginning January 1, 2007 shall be as follows:

- a. Minimum monthly charge for residential use is set at \$17.79.
- b. Minimum monthly charge for residential for Seniors is set at \$9.00.
- c. Minimum monthly charge for all non-residential sewer rates shall be based on a rate of \$10.90 plus a volume rate of \$1.10 for every 1,000 water gallons consumed.

Section 2. Water rates beginning January 1, 2007 shall be as follows:

- a. Minimum monthly charge for residential use is set at \$7.95
- b. Minimum monthly charge for residential for Seniors is set at \$7.95.
- c. With a volume charge for residential and Seniors at \$1.21 for each 1000 gallons of water used after the first 2000 gallons.

- d. Minimum monthly charge for commercial/government/schools shall be based upon the size of the meter connection and shall be as follows:

1"	\$ 33.75
1½"	\$ 67.30
2"	\$ 107.72
3"	\$ 235.85
4"	\$ 808.40
6"	\$1,684.17
8"	\$2,425.20

With a volume charge for commercial and government of \$1.53 for each 1000 gallons of water used after the first 2000 gallons; and

With a volume charge for schools of \$1.70 for each 1000 gallons of water used after the first 2000 gallons.

Section 3. Wastewater rates for the Townsite of Gadsden beginning January 1, 2007 shall be as follows:


- a. Minimum monthly charge for residential use is set at \$25.12;
- b. Minimum monthly charge for all non-residential sewer rates shall be based on a rate of \$34.50.

The wastewater rates for the Townsite of Gadsden include the 30% surcharge and the \$2.00 additional fee as per IGA Sec. 6 and Sec. 9.

Section 4. In the event of a conflict between the provisions of this Resolution and any other Ordinance or Resolution establishing or amending fees, the provisions of this Resolution shall govern. If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution.

Section 5: If any section, subsection, sentence, clause phrase or portion of this Resolution is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution.


