A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, COUNTY OF YUMA SELECTING THE FY 2007/2008 COMMUNITY DEVELOPMENT BLOCK GRANT PROJECTS AND AUTHORIZING STAFF TO PREPARE APPLICATIONS FOR SAME AND TO SUBMIT THEM TO THE APPROPRIATE PUBLIC OFFICES FOR FUNDING.


WHEREAS, the City of San Luis participates in the Community Development Block Grant Program (CDBG) and desires to apply for, receive, and expend FY 2007/2008 CDBG funds for the benefit of eligible individuals and households residing within its jurisdiction; and

WHEREAS, the State of Arizona Development Block Grant Program requires that an applicant requesting funds for CDBG-eligible activities adopt a Resolution certifying that the appropriate elected officials, after soliciting public input and after due deliberation, have selected those proposed projects that, in their judgment best meet the needs of the City of San Luis and its residents; and

WHEREAS, the City of San Luis has met all requirements concerning project solicitation, public review, and publication;


NOW, THEREFORE, BE IT RESOLVED that the City of San Luis, Arizona, County of Yuma selects the following CDBG projects for submission to the State of Arizona and further instructs city staff to prepare and submit the necessary applications for funding of same as follows: (1) up to \$587,773.00 of Regional Account ("RA") funds for City of San Luis Public works project, of which up to \$558,385.00 shall be allocated for Curbs, Sidewalks, Gutters, and Alleyways, and of which up to \$29,388.00 shall be allocated for the administration of the City of San Luis' CDBG projects; (2) up to \$300,000.00 for the purchase and outfitting of a fire truck, the funding application for which shall be submitted directly to the State of Arizona for consideration as a State Special Project ("SSP"); and (3) as an alternative or "back-up" project, up to \$30,000.00 of Regional Account ("RA") funds for the expansion of the City of San Luis Youth Job Training ("Youthbuild") in conjunction with PPEP, Inc. (a 501-c-3 organization) for income-eligible youth/young adults residing in City of San Luis, AZ, to be submitted if the San Luis City Council elects to not fund this project out of city revenues and only if it is also determined that said project is eligible for continued CDBG funding.


