RESOLUTION NO. 985

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AUTHORIZING A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AUTHORIZING THE ADOPTION OF VARIOUS FEES FOR LAND USE APPLICATIONS AND RELATED ADMINISTRATIVE FEES; REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the planning and zoning fees for Development Services (formerly called Planning & Zoning Department) were last updated in 2002 (Ordinance No. 191);

WHEREAS, the Department of Development Services has found that the cost of legal advertizing and outside review costs have risen to a point that the City actually loses money whenever an application is submitted;

WHEREAS, there are now activities and processes required by State statute which were not in existence when Ordinance No. 191 was adopted;

WHEREAS, Ordinance No. 191 is repealed by Ordinance No. 315;

WHEREAS, various related administrative fees for copying, sale of documents or CD's, and other administrative services are needed in order to provide for consistency in all City departments; and

WHEREAS, as required by State statute, the draft fees have been posted on the City website for 60 days (posted May 10, 2012 http://www.cityofsanluis.org/notices.html?article_id=527);

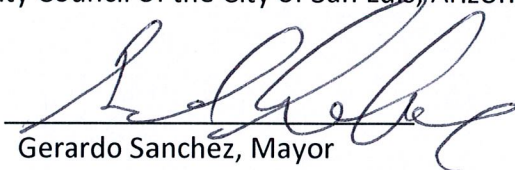
NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of San Luis as follows:

SECTION 1: That the attached fee schedule is adopted for use.

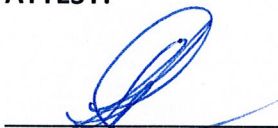
SECTION 2: In the event of a conflict between the provisions of this Resolution and any other Ordinance, Resolution, regulation, or policy of the City of San Luis, the conflicting provisions are hereby repealed, superseded, and replaced, and the provisions of this Resolution shall govern.

SECTION 4: If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of the Resolution.

PASSED AND ADOPTED by the Mayor and City Council of the City of San Luis, Arizona, this 10th day of October, 2012.

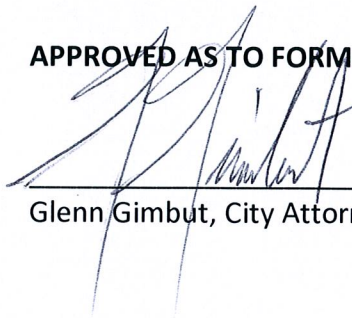
